- The accompany of the following documents:-
 - Photocopy of Registration with Pakistan Engineering Council valid up to last date of Calendar.
 - Photocopy of National Identity Card.
 - Enlistment of the department or Government of Khyber Pakhtunkhwa provincial work Department issued clause 26 of KAPRA act.
 - Registration with Khyber Pakhtunkhwa Revenue Authority.
- The eligible contractors /Firms are required to submit financial bid and reach to the office of the Director Works up to **03/03/2021 at 11:00 A.M**, the financial bid will be open on same dated **03/03/2021 at 11:30 A.M** by the Works Committee.
- In case the bidder quotes more than 10% below Engineer estimate the additional bid security shall be sought from the successful bidder only to the extent of bid more than 10% below the engineering estimate in the form of percentage. The amount of additional security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate and the successful bidder shall be bound to produce the additional security within three (03) working days from the issuance of LOP and failing which the procuring entity shall forfeit the bid security of successful bidder and may also initiate legal proceeding against the bidder who repudiated the contract under KPPRA procurement rules.
- The procuring entity may offer the contractor to next lowest bidder after due diligence in the context of financial difference between such two bids and the market analysis in order to discourage cartel making.
- The Bid should be quoted as Above-Below system on BOQ on MRS 2020/item rates.
- Conditional/Telegraphic tender shall not be entertained.
